GNPD contributes to create a beneficial environmental impact

24th Technical Forum: "Philippine Coal Plants: Coping Up with Climate Change Synergist: CJ Pascua







GNPower Dinginin Ltd. Co (GNPD) truly makes its commitment to the environment. With that, the company participated in the 24th Philippine Coal Plant User's Group (PCPUG) forum with the theme "Philippine Coal Plants: Coping Up with Climate Change" on April 27-28, 2023, at Seda Vertis Hotel in Quezon City. The event was attended by 19 coal power plants throughout the country and 270 individuals, all of whom shared the same goal of finding ways to mitigate the impact of coal power plants on the environment.

GNPD Plant Manager, Anton Besaris shared his insights about, "Energizing Power through P.R.O.G.R.E.S.S.", to show the company's approach to energy generation, technical side, and how it is contributing to the environment and community. The flagship CSR P.R.O.G.R.E.S.S. stands for - Protect marine life, Reforest Land, Optimize wealth from waste, Generate livelihood skills and income, Rehabilitate social infrastructure, Elevate educational opportunities, Safeguard quality health access, and Strengthen disaster resiliency.

GNPD has fueled community programs that aim to contribute to the environment's cultivation. These programs include initiatives to promote reforestation, waste management, and environmental conservation. The company is also working with local communities to support sustainable livelihood and scholarship programs, helping improve the lives of people in the region.

The company is technically a greenhorn to the coal industry. But as we move forward building the future through our massive transformative purpose, we commit to giving back to nature and take the community where the business operates to achieve the balance that we all aim in achieving a better future as we gear ourselves to the modern generation.

Opera-things

Ah, the GNPD Operating Department. This always sounded to me like a hospital department composed of surgeons and anesthesiologists. Other than this, perhaps the only thing you could think of now is that they are the reason why you and your crush (or friends) were assigned to different batches in our team-building activities. And they actually are. The schedule was made to accommodate 5 shifting groups who do not use the same calendar normal people have. But before you roll your eyes when you visit the central control room, let me introduce and give a few facts about the people who do not know what day it is anymore: The Operating Department.

The Operators are mostly from the three batches of cadet engineers who are products of GNPower Training Center's cadetship program. The first batch started in February 2017, long before the plant's towering chimney was constructed. The second batch came in on April 2018, around halfway through the chimney's construction progress. And the third batch came in on February 2020, just after the chimney was painted with red and white stripes. Altogether, they form one of the youngest groups of professionals for the largest power plant in the country.




The Operators are responsible for safely starting up, shutting down, and operating (not the kind surgeons do) the running plant within design limits. They also take the lead in monitoring and protecting the safety of personnel, the environment, the plant, and all its equipment. And lastly, if not most important, they make sure they have fun doing these things for 12 hours every shift.

The Operating Department has made strides in boosting reliability and efficiency proven by numerous personal best records broken in recent months. These include the Materials Handling Group's fastest ship unloading of just 1.43 days in November 2022. Unit I's fastest return to service of just 36 minutes after the grid-initiated SIPS trip. Unit 2's longest continuous running days are from January 9 to March 28, 2023 (78 days). This was previously held by Unit 1 which was from September 12 to November 26, 2022 (75 days). And of course, the Operating Department holds the record of the biggest population of any department in GNPD with 144 people. A record previously held by the Operating Department with 139 people.

These, trust me, are really good numbers in terms of how well our young power plant is performing; except for the population one, I don't know how it relates to the department's performance. These records only exhibit that the operating department sets the standards for excellence across the entire GNPD community. You can roll your eyes now.

Team and Employee Spotlight

GNPD Operating Team Bravo deserves a commendation for their excellent performance on February 9, 2023, and March 21, 2023, when they brought the Unit 1 back online on a record of 57 minutes and 36minutes respectively. Kudos as well to Dustin Jake Sta. Maria and Fretch Royette Ybanez on their exceptional performance to achieve the fastest time to return to grid after System Intergrity Protection





- GMEC Mechanical Turbine Section, Mike Lorenz Panganiban, Rowell Barata, Jose Caragay, Reynante Gatdula, Brian Flores and Eddie Enoc. together with Turbine Systems Engineer, Nessandro Duyan and Mark Joseph Sunga, planner Ryan Hope Serrano, and workshop machinist Regie De Leon with support from OMT Jefferson Villanueva. They performed rectification of several concerns/issues related to Unit 2 which eliminated critical risks on the Unit which could lead to much bigger issues if not addressed immediately. Specifically for the hydrogen leak, it could have been much worse if the leak was not addressed immediately.
- GMEC Team Echo achieved the first 100% start-up score and sets a new standard for the OPS Team. The 100% rating was attributed to focus operation, attention to details, and adhering to start-up procedures.



GMEC ISO certification journey continues

GNPower Mariveles Energy Center Ltd. Co. (GMEC) has again demonstrated its continuing commitment to employ sustainable practices and engage effective controls to minimize pollution and/or eliminate any potential adverse impact to the environment within the premises and its surrounding community with its achievement of recertification to ISO 14001:2015 (Environmental Management Systems Standard) on the recently concluded audit conducted on February 9 and 10, 2023 with zero nonconformity. The 2-day audit was conducted by a team of eight (8) auditors from TUV Rheinland Philippines, GMEC's certifying body service provider.

Simultaneously, GMEC has also proven its commitment in providing quality, reliable and cost-effective power to the highest standards of customer satisfaction with emphasis on maintaining an accident-free and healthy environment for its people and surrounding community by passing the surveillance audit of ISO 9001:2015 (Quality Management Systems Standard) and ISO 45001:2018 (Occupational Health and Safety Management System) which was conducted concurrently of the same audit team from TUV Rheinland Philippines. The audit was also concluded without any identified nonconformance for both management systems.

GMEC has been certified to ISO 14001: 2015 (Environmental Management Systems Standard) since 2017 while the certification for ISO 9001:2015 (Quality Management Systems Standard) and ISO 45001:2018 (Occupational Health and Safety Management System) was achieved in 2018.

The continuing certification to these international standards is GMEC's demonstration of its commitment to excellence as the first-choice power provider in the Philippines.

P167.4M worth of GMEC Cement Credits contributes to infra projects of Bataan LGU

The local government unit of Bataan has so far implemented 353 infrastructure projects in the province from the around Php 167.4 million-worth of cement credits of GNPower Mariveles Energy Center Ltd. Co.

In reference to the Total Ash Management Program (TAMP) of GMEC's by-product, ash, the company with the help of a third-party off-taker collects the ash generated from the combustion of coal and translates the price "paid" for the ash into credits for physical cement products that will then be utilized for the infrastructure projects of Bataan LGU.

Since the MOA was formalized last August 30, 2012, the Bataan LGU has already completed various infrastructure projects such as farm-to-market roads, multi-purpose halls, livelihood centers, community offices and service-oriented buildings, school buildings and daycare centers, hospital improvements, environment and safety-related constructions, among others.



Among the latest projects that benefitted from the cement credits this year are the Morong District Hospital and Bataan Peninsula State University both in Morong, Bataan. A total of 972 cement bags worth PHP 238,140.00 were donated for the construction of Bataan Peninsula State University Phase I, and a total of 22,073 cement bags worth PHP 5,407,885.00 were donated for the construction of Morong District Hospital.

"The partnership formed between GMEC, and the Bataan LGU has created significant contributions to the task of nation-building which includes the construction of infrastructure and development projects as part of our CSR PROGRESS flagship program," said GMEC AVP for Community Relations Arcel Madrid.

GMEC saw the potential of donating the cement as a unique opportunity for all parties to be part once more of a driven effort to safeguard the environment and build a nation, by transforming an erstwhile common by-product into an integral component of infrastructure progress.






Love runs through the Blood

GNPower Dinginin Ltd. Co. (GNPD) is a 2x725 MW (gross) coal-fired power plant in Mariveles, Bataan which is considered by far the biggest coal-fired power plant in the country today, spanning 30 distribution utility contracts and two retail electricity suppliers.

GNPD operates under the private limited partnership of AboitizPower's Therma Power, Inc. and AC Energy Holdings, Inc., Ayala Corporation and Power Partners Ltd. Co.

UNIT 1 of the project has been generating power since March 2021 and went on commercial operation on December 2, 2021.

Unit 2 successfully synchronized to the grid on April 23, 2022 and on May 27, 2022 it started to operate at its full load capacity.

Certificate of Compliance was awarded to GNPD Unit 2 last October 11, 2022. ■

GNPower Mariveles Energy Center Ltd. Co. is a private limited partnership registered with the Philippine Securities and Exchange Commission since 2007. It is a special purpose entity organized to engage in the development, construction, operation, and ownership of the 2x345 MW (gross) clean coal-fired power plant in Mariveles, Bataan, Philippines.

GMEC achieved commercial operation on January 27, 2014 for its two (2) units and it operates under the private limited partnership of AboitizPower's Therma Power, Inc. and AC Energy Holdings, Inc., Ayala Corporation and Power Partners Ltd. Co.
